

Levy dollars help bridge the gap between what the state provides and what it actually costs to educate our students. Every school in the district benefits from the levy dollars to support student learning. Among the items it helps pay for are:

- Safety and Security
- Technology Hardware and Software
- Curriculum Materials and Textbooks
- Facility Maintenance and Operation
- Extra-Curricular Activities
- Additional staff beyond those funded by the state

The levy helps pay for lower class sizes, teachers, support staff, training, instructional materials, technology, student programs like music, art, sports, and repairs and maintenance of school facilities.
